Pool Party Request

Members of Hanarry Swim & Racquet club (HSRC) may have pool parties under the following guidelines:

1. All Pool Parties held with more than six non-residents or requiring a reserved area must have prior approval.
2. Party Reservations are approved on a first come basis as space and staffing permits. **POOL PARTIES DO NOT INCLUDE USE OF THE CLUBHOUSE.** However, you may separately rent to use the clubhouse by contacting Lynn Dietrich at lyndtrick@hotmail.com.
3. Pool parties may be held between 9:00 am and 11:00 pm including regular pool hours except as noted in #4 below or during swim team functions.
4. Due to space and lifeguard availability, no parties with more than 25 people may be held during regular pool hours during the weekends beginning 4:00 p.m. Friday through Sunday.
5. The party may utilize up to half of the pool pavilion during regular pool hours.
6. Lifeguards will be paid at a rate of \$20.00 per lifeguard hour, with a minimum of \$40.00 per event. One additional lifeguard shall be required for any teenage party, college age party, or for any party involving alcoholic beverages. Lifeguard fees apply until the entire party leaves the pool deck.

The number of lifeguards required will be determined by the **total number of attendees, not just estimated swimmers.** (See attached Party Request Form for additional details.)
7. The \$2 per guest (non-members only) fee still applies for all parties.
8. Party host is responsible for cleaning up all party debris.
9. Party Host is responsible for setting up and taking down any requested tables and chairs.
10. Pool Party Request Form must be received by Positively Pools **TWO WEEKS** prior to the party date to ensure staffing.
11. **2 days'** notice is required to cancel a party and avoid lifeguard charges.
12. In the event of rain, host may cancel or postpone the party with four hours' notice.

Payment and reservation of services is applicable only to lifeguards and their time. Any arrangements with the pool or facilities must be made with the appropriate party. Lifeguards are provided at your request at \$20.00 per hour per guard, in the capacity of a safety precaution only. In the event of cancellation due to weather or lack of a scheduled lifeguard, the host will have the option of a full refund or rescheduling the party. Cancellation must be made at least four (4) hours before the scheduled party time.

The lifeguard will be in attendance to enforce all rules adopted by the pool being attended, and distribute consequences of breaking rules at their discretion. At no time shall the authority of the lifeguard be questioned. Continual disregard for lifeguard command can result in expulsion from the pool of the guest and/or a cease to lifeguard assignment on the job with no refund of payment. The pool and deck area surrounding it is the responsibility of the party host and shall be left in the same order as it was found by the guests. All trash, deck adjustments to furniture, and any evidence of the party shall be properly disposed by the party. The party host will be billed additional hours spent by the lifeguard to attend to any disarray left by the party.

As the party host I understand and acknowledge these terms of hiring a lifeguard for my private party. I also understand that I am responsible for the actions of my guests. Upon payment and registration, you will get a confirmation by phone or email on the lifeguard scheduled.
