

The HSRC Preschool Plunge Program ("PPP")

WHO: Adult members (21 years and older) and their children 6 years old and younger, in which the parent(s) has signed and submitted the PPP waiver

WHAT: Allowing said members use of pool during PPP hours

WHEN: 10AM - 3PM Monday thru Friday, starting the first day of the new school year until the Friday of Labor Day Weekend (GCPS school calendar)

WHERE: Hanarry Swim & Racquet Club, 595 Johannah Pl., Lilburn, GA 30047

WHY: This swim at your own risk privilege is a member benefit to provide those who are at home with their preschool-aged children greater access to the pool. With school starting earlier each year, swim opportunities are greatly reduced for these members during the second half of the swim season, which falls during the hottest part of the summer.

HOW: Members fill-out and sign the proper PPP waiver

PPP HOURS

August 6 - August 31

MON - FRI, 10:00am - 3:00pm

>>> RULES <<<

- Positively Pools or HSRC Pool Chair John Rowell MUST be called if a fecal "accident" occurs (John Rowell, 404-784-4979 or jrowell996@gmail.com)
- Parent MUST always be present with their child during PPP. No child shall be left unattended
- Defined: Adults are HSRC members who are 21 years and older. Member-children are 6 years and younger
- Use of diving board and deep-end is PROHIBITED
- Alcohol is PROHIBITED in fenced pool area for parents with children during this time
- Members will clean up all trash and leave the bathroom and pool area in order before exiting the fenced pool area
- Member agrees NOT to give out the gate code for any purpose. Lost codes can be obtained by contacting John Rowell
- Member will NOT admit or allow any person not associated with YOUR membership in the fenced pool area for any reason (i.e. if a member forgets their gate code and asks you for the code or asks you to open the gate for them)
- In addition to PPP rules, regular pool rules apply during this time (no glass containers, no running, no rough-housing, no smoking, etc.)

Swim At Your Own Risk Program for Preschoolers
Waiver of Liability

I, as a member in good standing with Hanarry Swim & Racquet Club (hereinafter referred to as "HSRC"), desire to participate in the HSRC swim at your own risk program for preschoolers (hereinafter referred to as "PPP"). In consideration of my participation, I certify that I am in good health and have no physical or other impediment which would endanger me while participating in the activities and that I have been released and authorized my doctor to participate in the activities of swimming at my own risk. I acknowledge and agree that these activities have inherent risks. I have full knowledge of the nature and extent of all the risks associated with these activities that include serious injury and death. Swimming can result in serious injury and death from diving incidents, diving off of a diving board, drowning, and incidents with other swimmers, falls on the pool deck, etc.. It can result in scrapes or bruises, broken bones or concussion and/or death or paralysis. I knowingly and freely assume all such risks. In consideration of my participation in these activities, I hereby (on behalf of myself, my legal representatives, signers, parents, heirs, executors, administrators, and assigns) release and forever discharge HSRC including its officers, directors, volunteers, employees, agents, etc. from and relinquish and forever waive any and all claims of causes of action arising out of my participation in swimming at my own risk for negligence, gross negligence, and such other actionable conduct resulting in personal or bodily injury, property damage or death. I also agree that I must use my gate code when entering the pool area. By using the gate code, not only am I assuming risk for myself but I am personally assuming risk for my party (including but not limited to: homeowners or renters insurance and personal assets).

I agree to adhere to the aforementioned rules and hours of PPP listed in this document as well as any additional rules posted on the current Hanarry.org website. At the discretion of the HSRC Board, anyone found to have violated any of the above rules may have their swim at your own risk privileges suspended or forfeited.

I understand as a member 21 years or older I must sign and acknowledge an understanding and appreciation of these rules and do so for the duration of my membership. I accept the liability, financial risks, inherent risk of the activity, and assume responsibility for myself and my family. I understand I must be present with my party at all times.
